Diversified Investing

Coleman Street Investments (CSI) is a pooled approach to discretionary portfolio management, which means your investment is in one of three CSI funds, each of which are managed to a specific investment objective.

Investing via a fund, as opposed to an individually tailored portfolio, allows for diversification across a broad range of asset classes which can help reduce volatility, even for smaller portfolios. A pooled approach can also be a cost effective means of ensuring your investments are managed by a professional investor, and what makes JM Finn's CSI service different is that, by investing via this route, you don't compromise the high level of personal service that is the hallmark of our success to date.

Flexible Investing

There are three CSI portfolios, each with a distinct investment objective, which invest in a range of asset classes via direct UK equities and bond investments, supplemented by investment funds for the international and more specialist asset classes.

A notable feature of investing via a pooled vehicle is the flexibility offered, as the funds are unencumbered by individual tax constraints, allowing the fund manager a greater degree of freedom when selecting investments. This helps the manager focus on meeting the individual investment objectives of the three funds.

As an investor in the CSI Service, you will be invested in one or more of the above funds, which are Luxembourg-based SICAVs (a collective investment scheme similar to a unit trust), which is recognised by the UK Financial Conduct Authority (FCA) and has HMRC reporting status.

Consistent Investing

The CSI funds are managed by one of JM Finn's fund managers via a consistent and disciplined approach. By drawing upon the wider, long-established investment expertise honed over the 70 years since the firm's foundation, the funds are focused on delivering superior, risk-adjusted returns over the long term.

The manager uses a dynamic approach to asset allocation, using the view of the in-house asset allocation committee as a guide, while drawing inspiration for investment ideas from the core stock list, which is monitored by the in-house research team.

The funds, unrestricted by sector and market capitalisation, will typically invest via direct equities for UK exposure and direct bonds for fixed interest exposure. This draws upon our core expertise whilst helping to keep costs down, as investing directly into stocks or bonds can often be cheaper than investing via third party investment funds. To access more specialist sectors, such as infrastructure or absolute return, or geographical exposure to the US or Japan, for example, the manager will generally use our preferred investment funds, across both the passive universe of funds, such as index tracking funds, and the actively managed fund universe.

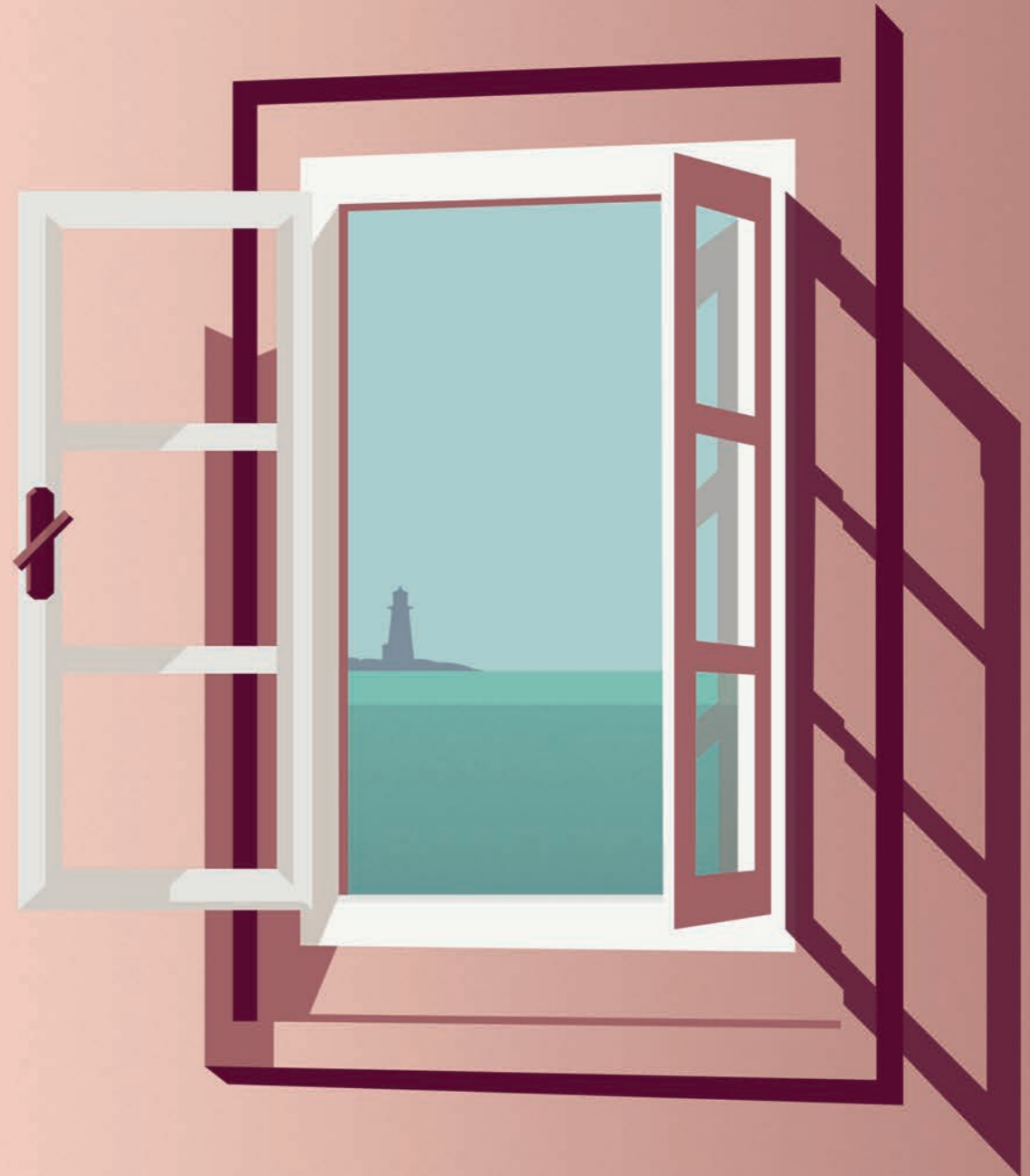
Transparent Investing
